FIRST TYME SUMMER TYME REPRISED

Report from Margaret Clauder and Earl Warren convention co-chairs

M - Well, the convention is over. The first EVER TCA summer time convention was judged a whopping success by all attendance standards. We had 154 clowns registered, plus several walk-ins for one day, (plus lecturers and dealers) - putting to rest the question "Will anyone attend a summer time convention?" The answer is a resounding YES! Also we had 11 Jr. Joeys attend the convention - that's at least 9 more than we have had EVER at a TCA convention. That's right! I've been coming to these things since 1991 and I have never seen more than 1-3 Jr. Joeys.

This summer convention allowed kids in public school to come because they were out of class! We even had kids competing (and placing) in competitions! How cool is that! We achieved our goal of getting young people interested in clowning. Last year the average age of the clowns at the convention was over the age of 45. We changed that this year.

If you did not attend this summer convention, or your kids missed it, I'm sorry. You missed some great lecturers, dealers, and parties. We had classes for the novice as well as classes for the seasoned professional. I for one was proud to see that 3 of our full time professionals in the DFW area even came to the convention - one for the very first time and said he loved it!

While the TCA membership did vote to do summertime conventions for 2 years starting in 2009 and it took us 3 years to go through the process of a survey and vote to move the date, a straw poll, non quorum vote initiated by the TCA board at the general meeting of this convention was the only requirement to invalidate the membership's prior vote and move the next convention back to the fall.

Now on to the negatives...

M -- Ok, we had some issues with the hotel. It was not a 4 star hotel. We checked out some of those and found that the price range was so high we did not believe anyone would come - especially in the current economy. In fact, we checked out 7 hotels in all for this convention. The problem we faced as a convention committee was that we had no idea how a first ever summer time convention would go over. Would we have enough attendance to break even? We certainly didn't want to go in the hole! So we did the best we could at picking an affordable hotel that had the space that we needed. Don't forget, the host alley signs a contract for several thousands of dollars - win or lose! **E** - You're right, Margaret. Frankly, we use too much space for the size of our conventions. That is not a new revelation! Many of us feel a need to streamline future conventions - especially competitions. The Sterling Hotel, out of seven hotels investigated, had the space, the price range and a willingness to *work with us* (a key factor). The hotel had enough space on one floor for all the events -- which was a positive for most attendees. And when it came down to the few days prior to opening, they bent over backward to provide us with more space than we actually contracted for - ATNO EXTRA CHARGE!

I have never attended a convention, in cities from Vegas to Washington or in Texas that could meet "full muster" if you *looked* for problems -- and I traveled the country off and on for almost 15 years and attended some very large conventions for various companies before I became a clown! The truth is, without more <u>attendance</u> -- translate that into *more revenue* -- we will continue having challenges finding problemfree locations in the future that will please everyone. Note that 2010 will be in a new convention center in a small tourist town one hours drive south of Fort Worth. The fact that it is new should please most; however, if this were in the Metroplex it is doubtful we could come close to affording the facility. **M** -- We have seen attendance at TCA conventions dwindle from a high of 225 when Happi Tymes hosted the convention in 1998 to just over 125 when Wichita Falls hosted it last year - in the fall. We were frankly not sure if we would break 100 attendees when we began our planning stages. Imagine if you contracted on a house without knowing if you would have a job to make the mortgage payments. That is the position we were in.

So, we did the best we could. This was the 3^{rd} time I have helped with a convention and Earl's 4^{th} . I noticed that as I work on more and more conventions how hard it is to do one well. There are all sorts of unseen problems and issues that no convention prep book can prepare you for.

I heard many wonderful comments about the lecturers, the dealers, things people learned and the fun people had at the parties. I heard laughter coming from the room during the skit performances and during the various competitions. Unhappily though, I heard way too many rude and snide comments from people regarding the convention. One couple in particular was so ugly to the convention committee that several of our members have vowed to not be involved in TCA conventions in the future - as a worker or an attendee! I was witness to this behavior and I was appalled that clowns who love children so much could act so hateful to fellow clowns. I was equally appalled that one of these people serves on the TCA board.

E -- As a matter of fact, the constant drumbeat of criticism leveled at the Competition Chairman, his assistants and judges during several recent conventions led Ed Fitzgerald to resign his position. By the very nature of competitions there will be people who see results differently, and from the outside looking in, feel it could be done a "better way." Finding someone with the experience, organizational skills, a willingness to put in the hard work and long hours that attendees and competitors never see is a major challenge. Just ask anyone who has filled the slot in the past. That very critical clown added the final straw! From the viewpoint of this writer, that person should temper their criticisms and remember they are occupying a position of responsibility.

M -- It breaks my heart that we would lose wonderful talented people over a few people's hateful and snide remarks.

Folks, if you wish there to be conventions in the future, one thing you need to do is be kind to those that work their tails off to put one on. Remember, we give up literally hundreds of hours of our time for NO PAY to do this. We did not hear any cutting remarks from former convention chairs, co-chairs, or committee heads. In fact, we heard thank you from those people. The people that were the cruelest were ones that we identified as not having served in the planning of any recent conventions.

I want to thank all the people that came to this convention. I hope you all learned a lot and will be able to become better clowns and entertainers because of it. I want to thank the competitors who spent many hours preparing. I wish to thank Earl Warren, who was my co-chair - he did a fabulous job! It's not easy being a senior citizen and putting in the hours and time that he did. If you noticed, at the convention he was very ill but put off going to the doctor until after the convention was over.

I wish to publicly thank Ed Fitzgerald who ran our competitions for several years - a truly thankless job and he did it superbly for most of that time without significant complaints. We will truly miss your expertise. I want to also thank Susan Keys who ran a dynamite Jr. Joey program with 11 Jr. Joeys! I hope she lit a good enough fire under these youngsters that they will continue clowning even when they cannot attend clown conventions in the future because they will be in school.

E - Margaret, thanks for the kind words - senior citizen? -- but there are always a number of high profile

don't forget there are many other "heroes" that work long and hard on the dozens of jobs necessary to make a convention a success. So, to all Happi Tymes and Metroplex alley members - thanks from the bottom of our hearts. It would never have happened without you!

We can't go back to August and start over. Our suggestion is to take what you learned from the tremendous pool of lecturer talent: Use the information to better your clowning - and forget the rest!

We salute you for coming and helping us prove that a Summer Convention can work.



From the Desk of the Secretary:

May 2, 2009 Board meeting/actions

The board met at the Sterling Hotel in Dallas, site of the 2008 TCA Convention set for August.

Representatives from the convention host alley Happi Tymes presented a reported on the plans for the upcoming convention.

Board approved a proposal for the awards and trophies for the 2008 convention from Image Engravers.

The board discussed possible options for the 2009 convention, related to location and dates and hosts. Andy A presented information about a possible location in Glen Rose Texas – Riverbend Retreat Center, a camp environment with cabins and meal plans. Board members discussed some pros and cons of this location. Also some members expressed concerns about the fact that the COAI Convention will be in Houston in April of 2010. There is much board concern about the declining attendance at the annual TCA conventions. Various ideas were considered, such as: skipping a year, eliminating or reducing competitions, reducing length of convention, etc. No decisions were made. Board members were encouraged to speak with members and alleys in their areas about these concerns and ideas.

Committee Reports:

Competition Committee: Ed Fitzgerald discussed items he will need for his committee at the convention. Lisa Ezell and Kim Grice volunteered to assist Ed with the computer work for the various competitions during the convention.

Ambassador Award: John Luce reported it was too soon to have received all nominations.

By-Laws Committee: Andy Quittner had no proposed changes at this time. There is some concern about the manner in which the area directors are elected but nothing was decided at this meeting. It was mentioned that some members in the Panhandle/West region were requesting that their director be replaced. The board agreed to accept ideas and comments at the next board meeting in August when all parties were present for the discussion and decision.

Education Committee: Aurora Krause (not present – sent a report with Kim Grice) – Kim requested advance information from the convention host alley regarding FIRST TIME attendees that are preregistered so that they can be contacted regarding the Buddy Program. Membership Committee: Kim reported that the 2009 alley reports are due on July 15.

Spark Plug Award – Andy Q will handle this for this year as he has all records in the database. The winner will be determined prior to the convention and Andy Q will notify Andy A so that the award can be prepared. He will also have Certificates for each member sparking at least one new member in the period.

<u>The Joey Journal</u> – Kay Quittner Editor – not present – report was given by Andy Q – reported that David Pitts is planning to retire as cover artist. He noted that he has received 56 responses to his survey in the last issue. He plans to recap these results for an article in <u>The Joey Journal</u>.

Website – Robert Whitley, webmaster was not present. Board discussed some needed changes, updates and improvements. There was a request to have the alleys listed under their respective regions. Andy A agreed to contact Robert with the suggestions and to confirm he wants to continue in this position.

Director Reports: Each area director discussed upcoming events in their regions.
