Randy Christensen: A Caring Clown

Many know Randy as a circus-styled, multi-talented show performer. He has done performances on stages around the world in auditoriums that hold thousands of people. Few know that he also has a history of engaging the smallest of audiences (one person) in nursing homes and hospitals. In 2001, Randy started the "clown on call program" and "clowns on rounds" for his local regional hospital in Green Bay, Wisconsin. But, to Randy, "caring clowning," is not just about the venue in which one is relating to an audience — it's about the attitude. Randy wrote this piece to share his thoughts on that topic:

...everywhere showing care

Calling All Judges for Kerrville 2014 by Patsy "Glitterbug" McMillan

Before we get started I would like to thank all of the clowns who have judged the competitions in the past years, along with those who are going to help me this year. It takes a lot of courage to critique your peers, but I hope we all do so with the hope of helping each other grow in our craft.

Competition should be educational and beneficial to all who come to be instructed in the art of clowning. This learning experience should be a positive one where they can reap the benefits of other clowns' expertise. All contestants have the right to be judged by qualified, knowledgeable judges who determine how well they present the different aspects of their clown.

TCA judges will be drawn from the ranks of current TCA members in good standing. They should have a minimum of five consecutive years experience in clowning, makeup and competition. Judges with extensive experience in all phases of clowning, performance and competition will be sought.

Judges should not only have participated in competition, but also should have won recognition in the Top Ten at the national, regional or local level. Their ability to do a good job can only be enhanced by having had broad exposure to the art of clowning.

A judge's job is to compare the contestants to the prescribed guidelines, not to one another. Judges should be knowledgeable of the TCA rules ahead of time in order to assist in being aware if the clown was following the rules for a particular phase of competition.

The TCA Competition Manual is posted on the website so you have plenty of time before the convention to review.

Before the competitions at the convention, there will be a Judges and Competitors meeting so that all the rules and guidelines can be reviewed as needed and answer any specific questions about the various competition categories the Clowns are entering. Please remember it is important that we attend this meeting, so look at the schedule when it is posted to plan your time.

Now that I have given you a lot of words please entertain the thought of being a judge if you have been judged and complained about their job, now is the time to step into their shoes and experience the impartial and uplifting job they have done. Along with the guidelines and your desire to help another clown grow, we will make this a painless experience.

Per TCA guidelines all judges should have received training to judge from one of the following: TCA, COAI, WCA, ISCA, or other judging seminar certified by the TCA Competition Director. Going forward TCA will keep a record of all members eligible to serve as a judge.

This is my second time being a Competition Director and I still need all the help I can get. Probably more now than before.

Last Walk Around: Lou HONEY Flowers-Stoddard by Mauri "Binkie" Norris

When Lou was 49 years old (in 1975) she and her husband Bob started getting interested in clowns - in particular she wanted to paint clown portraits. So they began traveling to visit circuses and fairs where they would find good Lou painted many clown subjects. portraits over the years and her interest in clowning grew. Eventually she developed her own clown persona as HONEY the Clown and began performing all around her home area of Duncanville, TX. Once, while Lou and Bob were visiting with the star of the JoJo Jingles Show (a stand-up comedy revue), the star of the show encouraged them to join Clowns of America (COA). They did and a whole new world of clowning opened for both of them. Not long after Lou became HONEY, Bob became BOPPO and they often worked together around the area at places like the Texas State Fair, Traders Village and Six Flags Over Texas. Honey even began standing in for JoJo Jingles in his traveling shows.

Lou and Bob were involved in forming the first Texas COA alley – Texas Mid-Cities Alley #85 and the alley clowns worked with Dr Pepper Circus and partnered with Emmett Kelly, Jr. Lou and Bob became close friends with Kelly.

Lou still loved painting clown portraits and had numerous prestigious showings but she loved her clown family the most of all. She once said, "The time I spent with my clown friends will always be a bright spot in my life."

Lou and Bob helped to found the Texas

Clown Association in 1982. Lou served

in various Board positions over the early years of TCA and she assisted Bob as he Edited The Joey Journal for many years. Lou received many awards over the years, including the TCA Ambassador of Clowning Award in 1991. But according to Lou, "the greatest reward was seeing the smiles of all the little children over the years. That's what kept me going."



Lou's health was failing for the last few years but many of us were lucky enough to get to visit with her briefly at the awards banquet of the 2013 TCA Convention in Irving. A special thanks to Jeanette DUSTI Sanders for arranging to get Lou to the banquet. (Jeanette is Lou's niece and certainly was inspired by HONEY to became DUSTI the Clown.)

Lou/HONEY was featured in a cover article in the Southwest NOW Magazine for Cedar Hill/DeSoto/Duncanville in the October 2001 issue. She was very excited and proud of this honor.

Lou held TCA membership #10. She passed away peacefully on April 26, 2014 and TCA lost an Icon.

Sculpting A Routine By Randy Christensen

I believe that it was Michelangelo, after sculpting his figure of David, was asked how he came up with such a masterpiece. He replied, "Cut away the parts that don't belong until you set the angel free." (my paraphrase)

During this past summer I performed twenty-four camp programs, numerous Vacation Bible School presentations, Sunday kid's church services, performances at the kids activities at the Sonshine Music Festival and six programs with DonB! and Ben Christensen on the L.O.L. tour. It's been invigorating and tiring at the same time!

With the opportunity to share numerous camp programs, and also perform the L.O.L. show multiple times, I was able to begin to sculpt some of my routines. When I first started performing them, they were kind of rough-hewn. I had the ideas, and I knew what I wanted them to look like when I was done, but there were a number of elements that I needed to cut out without touching the integrity of the routines.

For the L.O.L. tour Ben, Don and I shared our ideas of what we believed should happen in the show. It took a while for us to all begin to see what the "angel in the stone" should look like in the end. We had to cut away parts of the show. We needed to drop certain jokes that

were funny—but didn't fit the flow of the show. We added in short bits and transitions that helped the audience feel the flow between performance segments.

Honestly, it was hard. Sculpting is hard work. And I think, just as an artist working on stone, clown artists need to get a picture of what the final routine looks like. BUT, as a routine begins to flow, the artist must be willing to let go of his pre-conceived ideas and allow the pure, honest comedy to flow from the character and the situation. In that way, many routines can write themselves! The hard part is letting go of the material that I like-because I like it! But in the end, it's better to chip some of that away so it doesn't clutter the audience's view.

Okay. What am I practically saying? Here it is: If a joke doesn't fit the routine (or your character) save it for a different time. Don't force it into your performance. If you have a picture of what a routine could be, and you're not there yet, don't give up on the routine. Just chip away a part here and a little part there. Add in another bit (like a piece of putty.) See if it fits. Gauge your audience's response. Most of this work happens in thought and practice, but ultimately you don't know if it works until you are in front of an audience.

Here's an example: On the L.O.L. tour, Don, Ben and I ended with a 12 minute juggling and object manipulation routine. As we approach the end, I climb up 6 stacked chairs - which places my head at about 20 feet. It's cool. We wanted to have a reason for me to go up the chairs. Something that made sense. So, I had an idea. I came out with a paper airplane and made it fly at the beginning of this sequence. Later, during the juggling, I stood on a chair and pulled out the airplane to make it fly again. Ben, yelled, and stopped me, giving me another chair so I could climb higher before I let go of the airplane. Liking the idea, I stacked that chair on top of the other. This continued on until I reached the very top. Slowly, I stood up straight and pulled the airplane from my pocket, then let it fly down to the audience. Chuckles and cheers followed. I then needed to dismount the chairs so I could get down and get the airplane once again. We headed towards our final choreography, then exited the stage before our final curtain call. Don had an idea. Instead of just running off stage, we held out our arms and acted like we were airplanes flying off stage. That made sense, and simply tied the airplane concept into the performance from start to finish.

Because we continue to work these types of routines in front of an audience, and are willing to cut away parts—that many would say are "good" -- we are able to come out with a better presentation for our audience. That's our goal.

Don't be satisfied with "good" if you can do "better." Cut, and sculpt and share the art of clown with your audience.

Well I'll admit it, time has slipped up on me again. I have been so busy with the "business as usual" parts of life that I have again waited until the last minute to download all my stored up verbiage.

This has been a month of mixed emotion for most of us. We all feel the pride of living in a country where people will not only fight for our own freedom but will sacrifice their lives to insure the freedom of others. With this patriotism come the concerns of battle. We are all worried about our soldiers and the soldiers of this coalition force.

We fear for their safety and the families they leave behind. We fear for the innocent that may be caught defenseless in the crossfire.

Most of all, as clowns, I think we worry about the children, and I don't believe that it matters what side of this war they are on.

Recently, I received a telephone call that doubled as an induction notice complete with traveling orders. I was told about a different kind of war. The enemy was cancer and the soldiers were children. The other clowns and I were to be sent directly to the front lines. Upon our arrival, it was clear that the Star Gate Sports Horse Ranch had assembled more talent than a Bob Hope USO show.

The miniature troops were greeted by a host of entertainers from clowns to Dallas Cowboy Cheerleaders. After being welcomed, they were all given the same duty assignment: have fun; the place is yours.

If I were asked what part we played in this skirmish, I would say without reservation that we were the medics of the group. Not doctors of the body but physicians of the soul.

We were dispensers of laughter and specialists of humor. An exhibition barn filled with music and merriment replaced the treatment room. For a moment in time stick horses replaced hospital beds and stickers the need for bandages.

Rubber gloves and radiation could not be found. On this day, standard issue protection was a balloon helmet and standard weapon a balloon sword. With knees in the sand, these medics administered the elixir of laughter, seen by the eye, heard by the ear, and made stronger by the touch.

This scenario takes place day after day, year after year all over the country. Because of clowns like you somewhere someone's spirits are being lifted, laughter is flowing, and somehow it doesn't matter where it hurts anymore. You deserve a standing ovation but thrive on the grateful thanks of a grieving parent, or the first signs of the aged returning smile. I could go on in volumes of how the world has expressed it's admiration of the clown profession and what they perceive a clown to be, but I would rather leave you with this.

The man that said these things is Gary, an American Airlines aircraft mechanic, with a degree in literature.

He expressed his admiration for the profession of clowning by saying, "A clown is a concoction of actor, comedian, illusionist and craftsman."

You stand before a world of strangers weaving a spell of humor. Instead of hiding your flaws, you exaggerate them and by doing so make yourself even more humorous.. You walk a tight rope of failure without a net in the hope of making this world smile. You offer the world what it needs most, a smile, soft touch, a gentle word and a carefree moment.

Yeah that about sizes it up.

Ambassador of Clowning Award

It is time to begin the process for nominations for the 2014 Ambassador of Clowning Award. Recommendations for considering applicants are:

- Nominee must be an active (current in membership) and a participating member of TCA.
- The nominee must be known for his/her dedication and promotion of clowning without personal gain.
- Should be a well-rounded clown, someone who gives to the community, is an active volunteer, and who is professional in the art of clowning.
- Nominee should promote TCA in all facets of clowning, should strive always to be positive, upbeat, agreeable, have a fair attitude, be willing to share ideas, and be available to assist with a smile.

Please send a letter giving the reasons you feel your nominee should be the 2014 TCA Ambassador of Clowning. The letter should include examples of the points listed above and have sufficient details describing the nominee to the Committee members as if they do not know the person being nominated. Some points to address might include:

- How long has the nominee been an active supporting TCA member?
- Have they held any Board positions or worked on committees within their alley or TCA?
- How do they support and promote TCA in their clowning?

- How have they exhibited extra-ordinary clownmanship?
- How has the nominee shown to be positive and sharing? Are they unselfish in assisting others, caring, and most of all, just there when needed with no thought of being reimbursed for their time or efforts?
- How have they displayed being a well-rounded clown; someone who is an active volunteer in the community and demonstrates professionalism in the art of clowning?
- How has this nominee shown his/ her dedication and promotion of the art of clowning in assisting others?

Nominations can be accepted from active TCA members only. You may want to verify that your nominee is a current member (TCA annual dues are due on April 1, 2014). The nominations will be considered by the TCA Ambassador Committee which is made up of previous recipients. The award will be presented during the Award Banquet at the annual TCA convention.

All nominations must be submitted in writing by email or regular mail by September 1, 2014. Nominations received and/or postmarked after the deadline will not be considered for the Award.

Las cartas de nominacion deberia explicar porque tu candidato deberia ser considerado para recibir el premio, junto con ejemplos de los puntos mencionados arriba. No es suficiente el solo nominar una persona. Las nominaciones seran evaluadas por el comite consistiendo de ganadores de años anteriores. Recuerda, aunque la mayoria de miembros del comite son miembroas activos del APT, esto no significa que conozcan a todos los miembros. Asegurate de incluir hechos asi como:

• Cuanto tiempo el nominado ha sido

- promotor de la APT?
- Han mantenido posiciones en el area, en el consejo de APT, o como miembro del comite?
- Como apoyan y promueven la APT?
- Como han demostrado y exhibido sus talento extraordinarios de payaso?
- Como ha demostrado el nominado su buena actitud, optimismo, comunitario, etc? son compasivos al ayudar a otros, carinosos y mas importante; estan ahi justo cuando mas se les necesita sin siquiera pensar en reembolso o compensacion personal por su tiempo y esfuerzo?
- Como ha demostrado ser un payaso activo; alguien que aporta a la comunidad como voluntario?. Demuestra profesionalismo en el arte de ser payaso?
- Como el nominado/a ha demostrado su dedicacion y promocion al arte de ser payaso al asistir al projimo?

Las nominaciones seran solo aceptadas de miembros ACTIVOS de la APT (asi que asegurese que la membresia este al corriente, la proxima factura sale el 1ero de Abril.) Los nominados tambien deben estar al corriente con APT (si quieres cersiorarte del estado de membresia, contacte a Mauri Norris). Asegurese de incluir su nombre y numero de miembro APT en tu carta de nominacion. Al igual, incluya el nombre REAL y profesional del nominado. (incluya su informacion personal en caso que el comite desee hacerle algunas preguntas sobbre su nominacion). El comite juntara todas las nominaciones y examinara en grupo para poder llegar a una decision final.

Empieza a pensar que miembro de la APT tu crees que se merezaca mas el Premio como Embajador de Payaso en el 2014. Ya que sepas, somete tu nominacion entre el 1 de Abril y 1 de 1 Septiembre del 2014. Puedes someter tus nominaciones ya sea por correo electronico o correo regular.

Quick Tip: Using Clipart to Make Props by Greg "Zoots" Stanford

Have you ever been looking for an object to be a prop in your skit, puppet show, or walk around and just couldn't find what you were looking for? I have. Let me share an idea with you that I use all the time.

Instead of looking for an actual object for your prop, why not find a good looking image online and make your prop?

Here's what I mean. I needed a milk carton for a puppet skit. I could have gotten a real milk carton (can you even find cartons anymore?). However, I need a large, flat prop to travel with. So I logged on to my favorite clipart web page, iclipart.com (this is a subscription based site) did a quick search for "milk carton"

and found a good looking image.

I printed it off as big as I needed it. Then using a spray adhesive I mounted it on a piece of foam board and cut it out with an Xacto knife. By spraying both the back of the paper and the front of the foam board, you create a permanent bond. For puppet props I add a paint stir stick that I paint black to serve as a handle. I add a piece of coat hanger to the handle to hang the prop from the stage.


