# Texas Clown Association Board of Directors Meeting Minutes July 17, 2010

Texas Clown Association board of directors' meeting was held on Saturday July 17, 2010 at the San Marcos Library in San Marcos Texas. Meeting was called to order by President Andy Anderson at 10:10am.

Board members present: Andy Anderson, Kim Grice, Andy Quittner, Mauri Norris, John Luce, Christie McNeill, Peggy Barton, Steve Dilsworth, Joyce McKelvey and Dale Flashberg. Jeanette Sanders arrived at 11:30am.

Minutes of the TCA Board meeting of 5/15/2010 were distributed to all board members via email. Andy Q moved to accept the minutes as distributed. The motion was seconded by Christie and passed unanimously.

Treasurer's Report – Andy Q distributed a financial report (actual versus budget). Current bank balance is \$28,413.38. There is currently no CD, all funds are on deposit in interest bearing (money market0 account. The present Joey Journal mailing list has 257 names. Expenses for 1<sup>st</sup> 7 months of 2010 are slightly over budget – esp due to membership solicitation. Andy Q agreed to distribute membership rosters to all board members – 1) paid members and 2) memberships that expired on 3/31/2010. Mauri gave Andy Q \$48 she had collected for patch sales. Additional patches were sold to board members at meeting.

#### **CONVENTION REPORTS -**

2010 – Granbury - It was noted that there needs to be better control of the TCA membership requirement for persons registering and attending the convention. Andy Q noted that he expects to be in Granbury in time for the opening of the convention registration desk. Andy Q will supply host alley a list of PAID TCA members just prior to the convention so that the host alley can "FLAG" any registrants that are UNPAID. There are 49 persons pre-registered for convention to date. The correct hotel rate is \$79.99 (though it was previously published as \$79). There will be time in the convention schedule on Saturday afternoon for folks wishing to site-see in the Granbury area or go to the Granbury beach. The host alley hopes to have the paradeability competition outside on the boardwalk (weather permitting). The banquet entertainment is set (a singer – mostly easy listening/soft music). Most of the lecturers and vendors are set. Need hosts for hospitality room on Thur and Fri nights. Are asking alleys to donate money to the hospitality and local hosts will man the room. Sponsors are welcome to assist but hope that not requiring 'manning of the room' will encourage others to support. Sponsors will be acknowledged in some manner. Wed night will be the TCA Boards' Ice Cream social (hospitality) and Mid-Cities will host on Saturday night (as the 2011 convention hosts).

Board members are reminded to bring an ice cream scoop and a topping. CowTown is trying to be "green" this year and recycle – so anyone having extra lanyards or notebooks that they will donate should let Andy A know. Andy Q will send payment to CowTown for 4 TCA paid convention attendees: Kay Q for JJ Editor, Christie M for Competition Chair, Robert Whitley for webmaster and Gema Anderson for the 2009 Sparkplug award. These are paid at the original/lowest registration rate. Next Joey Journal is the Convention issue. It must be mailed by the end of August. That will be the last issue for unpaid members. The board needs to purchase an ad for the convention program. Peggy B will design ad (and Andy Q needs to send payment). Also, Andy A will try to coordinate roommates if there is any need.

COMPETITION REPORT – Christie M is working with Robert Whitley to be sure all of the score sheets and tally programs are functioning prior to the convention. She still needs judges for the various competitions. She asked for the schedule of the competition dates/times so that she can provide the CUT-OFF times for the convention schedule. Tentative schedule is pretty set and posted on the website. Andy A will send Christie the most recent schedule. <u>The Joey Journal</u> needs to include an article/note reminding participants that they need to ensure that any music CDs for skits and/or performance competitions will play on regular equipment. This is part of the new/revised TCA Competition rules posted on the website.

Also, it will be announced during the competitor's meeting at the convention. It was noted that the board meeting is set for 5:30pm on Wednesday, so Christie will need non-board volunteers to man the competition table during the meeting. The general membership meeting is at 4:00pm on Thursday. It was noted that the POINTS LEVELS need to be reviewed on the new score sheets. Currently have many categories with scores of only 1-2-3. This needs to be changed to prevent multiple ties. Prefer a 10 point system.

### COMMITTEE REPORTS -

TCA AMBASSADOR AWARD – Mauri reported she has received no nominations to date. The deadline is September 1<sup>st</sup>. Needs to be announced again in <u>*The Joey Journal*</u>. It has happened before that no nominations were received and also it has happened that the award recipient was not in attendance at the convention to receive the award.

BY-LAWS – Andy Q reports that there are no proposed by-law changes for this year.

EDUCATION – Joyce M mentioned that she is not interested in this position at this time. Andy A mentioned that Rhea Anderson has expressed a willingness to take on this position. Rhea says she needs help this first year, especially since she is helping with the convention hosting. Both Joyce M and Kim G are willing to assist this committee (however, Kim will not be attending the convention this year). Mauri moved to nominate Rhea Anderson for the position of Education Committee Chair. Peggy seconded the motion and it passed unanimously.

HISTORIAN – Susan Keys – reports she is putting some old TCA stuff on CDs and will submit a budget soon.

MEMBERSHIP – Kim reminded the board members that all alleys need to submit their annual reports soon. The form is posted on the TCA website. Area directors need to urge alleys to get their reports in timely. Reminder: ALL OFFICERS OF TCA ALLEYS must be TCA members. Kim will prepare a list of TCA membership benefits for publication in The Joey Journal. It was noted that Junior members do not have to have a parent member (though younger Jr members are encouraged to have parental supervision). Andy A sent out letters to the 2009 convention attendees who were not yet registered for the 2010 convention and got a good response. NEED TO TALK-UP TCA AT ALLEY MEETINGS. Sell patches - \$6 each. Also, Andy A will contact the Texas clowns at the 2010 COAl convention to encourage TCA membership and convention attendance. Perhaps we could have some sort of contest for alleys that have the highest percentage of TCA membership? Would need some reward. Perhaps: Alley of the Year?

#### NOMINATING COMMITTEE – Jeanette Sanders

Jeanette mentioned that she was still waiting to hear back from several alleys. Presently a number of the current board members are willing to run again for their current positions or another board position. Current known nominees:

President – Andy Anderson V. President – John Luce Secretary – Mauri Norris Treasurer – Andy Quittner Sgt at Arms – Steve Dilsworth Area Directors: Peggy Barton and Jeanette Sanders are willing to run again.

Dale Flashberg, Joyce McKelvey & Steve Dilsworth are not planning to run for area director positions.

More nominees are needed for the slate to be published in the next issue of <u>*The Joey Journal*</u>. All board members are encouraged to ask around and to send anyone interested to Andy Q for the nomination slate.

Joyce – would like to have a current list of TCA members and wants to clarify the "particulars" of the various make-up types (esp differences between white-face and auguste). Joyce will write an article for <u>*The Joey Journal*</u> reminding people to prepare and read the rules and note the various differences between the different categories. She would like to know if there is a possibility of adding Face Painting competition at TCA. She asked Andy A to add this topic to the agenda for the General Membership meeting.

Dale – working on their alley report at this time. She enjoyed serving on the board these last 2 years and will now be moving on to other clown endeavors.

Steve – the 2010 COAI Convention is fully over and the profit has been transferred from the convention account to Cheerful. Clown School is ongoing at this time with 20 students.
