- 3. <u>Convention report</u> 94 people preregistered not including the 10-12 lecturer/dealers on the list. Room block has been exceeded. Agenda schedule is 99% complete. Current agenda is on website for review.
- 4. Committee Reports
 - Ambassador An article was written for the Joey Journal in both English and Spanish.

 Bylaws –A change was discussed regarding electronic attendance at meetings. Tried to

 Skype with Kim and Olivia and it was not successful. According to bylaws you are not part of
 quorum if not present in person. "Skype usage and electronic, phone conference for board
 meetings was discussed and it was decided to table it until after the new board elections."

 It was a unanimous decision to table it. Such a change would require a bylaw change.
- 5. <u>Education</u> The Board would like to recommend to the Education Committee that the scholarship guidelines should be relaxed. Individuals should be a TCA member for 1 year before applying for scholarship. The Education Committee needs to present new time guidelines to Board for approval.
