Voncille Hardy motioned to approve treasurer's report and Linda Greene seconded – all approved and Cindy will file for audit.

There were 51 non-renewals for 2017 including ambassadors and lifetime. This seems to be consistent of 50 non-renewals per year. Patti Gilbert asked if we could get a list of individual alleys to see if we can get the members back and was told that the way the database is set up this is next to impossible.

4. Convention Reports:

2018 Mid Cities Convention Report – August 1-5, 2018 – Susan Keys and Cinde Sanders

- Finally here having normal last minute things but all can be resolved by phone call. Candy
 of the hotel is on top of everything. Asked if anything needed to be addressed.
- Did have judges and competitor meeting this afternoon, thought Diana was doing it but she didn't show. Competition hat would it be ok for a Ringling clown to sit in on the judging since they are not part of TCA. Make sure they have guidelines to follow. Asking the judges to put in constructive criticism in each box. Ringling clowns were approved to judge if they want to. Have been asked to put up a "connect" board for everyone to leave notes if need to get lost keys, meet with people, roommates, etc. Had 88 pre-registered with a lot of walk-ins. 1 day registrations do not need to be TCA members. Greg will be recording events. Trying to work on wi-fi issues with the hotel.
- 2019 Cowtown Convention Report Andy Anderson and Martha Warren
- Andy said the dates for next year is September 25 29th at Holiday Inn 3005 Airport Freeway which will be \$109 per room plus they have refrigerator and microwave in it. At this convention they have a \$130 registration fee, \$145 through end of December, \$160 until the end of March, and \$175 until end of June after July 1st and at the door registration will be \$195. Forms will be at their booth. Angel Ocasio is headliner and theme is "Going back in time". Will have next board meeting at this venue hopefully. Cowtown is putting on this convention in Bedford.
