## GENERAL MEMBERSHIP MEETING

Date: September 22, 2016

- 1. Meeting was called to order at 4:15pm. Andy asked the membership to review the previous minutes that were handed out while he goes forward with the other agenda items.
  - <u>Board Members Present:</u> Andy Anderson, Christie McNeil, Patsy McMillan, Mauri Norris, Kathy Keaton, Martha Warren, Judy Cornett, Voncille Cox, and Diana McCurtain-Talbert. Mentioned that Greg Stanford was and Area Representative and the Competition Chair and he would be in after completing the balloon competition.
- 2. <u>Minutes</u>: Andy Anderson asked if everyone had a chance to look over last year's minutes, and if there were any questions or corrections. W T Keys motioned to accept the minutes as distributed to the membership and Debbie Garcia seconded. All agreed and was passed. Patsy McMillan will send to Greg Stanford to be published in the Joey Journal and to be put on website.
- 3. <u>Treasurer:</u> Mauri Norris stated that the bank balance as of 9/19/16 is \$39,977.44. This includes four Joey Journals and that we are \$600 short of dues at this time. The convention expenses are not reflected in this report. Proposed budget for 2017 shows we are a little less robust in the projection and showing a loss for next year. If we lose \$2,000 each year it eats away with what we have. Mauri asked if there were any comments or questions about the treasurer's report. Peggy Barton motioned that we accept the Treasurer report and W T Keys seconded. All in favor and was accepted unanimously. Mauri Norris will file for audit.
- 4. <u>2016 Convention</u>: Kathy Keaton says it seems to be going pretty good at the moment, with only a few snafus at this time (which is standard). Kathy then urged everyone to visit the museum and witness the shooting of the cannon. Advised performance competitors to eat first so they won't be so stressed about getting ready for the evening competition. Still selling the logo cards for a chance at winning \$500 Kathy then introduced a staff member (didn't catch his name) to give us the history of Fort Concho, a frontier army post from 1867-1889 which is one of the best preserved forts of the Indian Wars Era.

Kathy then introduced Catie Weidenhofer who is the Director of their Non-Profit of choice "San Angelo Safe Kids". Catie, in turn, introduced one of her safe kids who said a few words — so few I didn't catch them. Catie then gave an overview of their program to keep the kids today safe.
