



Clowning around starts first children's clown club

Grenda Hare didn't have much of a childhood growing up in an orphanage in England. But at 50, the Dallas resident has found a way to be surrounded by children and stay forever young.

She became a clown.

"I was deprived of a childhood, so I created my own," said Hare, known to hundreds of children as Poppins the Clown. "I'll never grow up."

Her clowning glory is the founding of the first children's clown club in Ameri-

ca.

The club will hold its first meeting Oct. 1 at the Metroplex Art Center in Dallas and is designed to teach children the art of clowning through regularly scheduled meetings and workshops. No grown-ups are allowed.

"It's all for the children," she said.
"Children are natural clowns anyway.
It's easy to make clowns out of them."

In her class, the children will learn much of what she has learned herself in the three years she has been clowning: clown makeup and costuming, juggling and magic tricks.

It's not all fun and games. Hare includes a subtle message in each meet-

ing.

"I try to build confidence and self esteem in the children," she said. "Kids are under a lot of pressure these days. I see myself in a lot of the kids who are scared to speak from having been knocked down all the time."

For a clown, she takes this part of the

act seriously.

On the club application form is the clown oath which says, in part, "I do hereby promise that while in clown makeup and costume that I will not swear, smoke, use drugs or drink alcoholic beverages. I will always look my best when in makeup and will always stay in full costume while in public. I will treat all with dignity and happiness."

Although the oath — taken from Clowns of America's National Clown Pledge — applies only to clowns in costume, Hare said she tries to get her pupils to carry that philosophy into everyday living.

Hare took her clown name from the popular Mary Poppins character — a natural since she was a nanny in Eng-

land.

That was many years ago. Since then, she said she travelled the globe and worked in occupations ranging from hotel management in Wales, modeling in England, the ceramics business in the Bahamas, in addition to child care and a catering business.

But her favorite, by far, is clowning.

"It's absolutely Number 1 because there is no stress involved," Hare said. "I keep busy, but everything I do I enjoy. I'm happy and that's the first thing in life."

She has no children of her own, but considers her family the many children who have seen her perform.

"I have always loved children and children have always loved me." she said.

"Children will tell things to a clown that they won't tell anyone else," Hare said. "They put a big trust in clowns. They feel clowns won't betray them."

"Kids really believe you're a clown. The minute I take my gloves off, I've lost my identity," she said. "They see the flesh. I'm a person."

Although she prefers young audiences because "there is nothing more wonderful that seeing those kids' faces light up," she said there's no age limit on fun.

"Everybody loves clowns, from six to 60," she said. "There's something about a clown that is magical."



Larry Kibbey makes his living sharing laughter while teaching others to take the world and themselves less seriously

Three teen-agers stretch out in front of a mirror on the gymnasium floor and put on clown faces with white greasepaint, outlining them in black. Soon they'll color their noses red, or attach round, red rubber ones that squeak when they're squeezed.



The kids are oblivious to the activity around them — girls and boys between 13 and 17 years of age dotting

At work their cheeks with freckles, putting on curly, red

wigs, or mussing their otherwise perfect hair. Soon they're wearing oversized, mismatched shoes with baggy, patched pants, plaid coats and polka-dot ties.

There are squeals of laughter as each teen tries to outdo the other with outlandish garb. For once, these kids — many of whom have drug, alcohol and emotional problems — aren't worried about looking or being "cool."

The reason is one heavyset man sitting in their midst, busily gluing squeaky noses to their faces. His name is Larry Kibbey, or — as he is known professionally — Kibbey the Clown.

ibbey, 51, started clowning in 1948, but didn't turn professional until 1976 after much coaxing from other clown friends and an ultimatum from his doctor — either get out of the bill collecting business or his high blood pressure would kill him.

"The only thing I wanted to do was be a clown. So I started looking for jobs," he says. At the time, there were no clown schools. He picked up his training by working with professional clowns and studying on his own.

ciowns and studying on his own. Kibbey has clowned for everything from furniture stores and restaurants to carnivals and festivals. Since he founded the Houston Clown School (now located in Stafford) in 1978, he's taught nearly 3,000 amateur clowns and 306 professionals, in addition to conducting workshops around the country. He has an extensive library of clown books, memorabilia and photographs.

Kibbey says he has the largest performing clown family any-where, consisting of four generations: his adoptive mother, "Bim," 78, his wife, "Cotton Candy," 50; his children, "Hobo Joe," 30; "Pokey," 25, and "Sunshine," 29; daughter-in-law "Hokey," 21; and grandchildren

"Hokey," 21; and grandchildren Christopher Kibbey, 10, Lanny Kibbey, 5, and Brian Ash, 6, (who haven't taken clown names yet.) and "Houdinki." 4,

Last week Kibbey spent a few days working in a volunteer capacity with more than 30 teens at Spring Shadows Glen, a Houston psychiatric hospital, teaching them some history, tradition and techniques of clowning. But in Kibbey's opinion, he's been teaching more than that.

"If we've done our job properye're helping them learn to build bridges and tear down fences," he says, referring to the way the kids were opening up to one another and having fun.

"The clown brings out the best in people," Kibbey says.

"There's an instant feeling of belonging. It's so easy to return love as a clown. The other day, when my wife and I put clown suits on, there was a flow of good feeling. Today, as they put on suits themselves, they have that same feeling for each other. I didn't see that before."

"A lot of people say, 'I couldn't do that (be a clown). 'I went along as Mrs. Clown, carrying supplies, until I realized he was having all the fun and I wadoing all the work," says Kibbey's wife, Carolyn — now a clown herself, and helping her husband with this workshop.

eated near the middle of the gym, Kibbey smears red color on one girl's face. "Carolyn, the bag of noses," he calls out. Soon he's fumbling in a suitcase full of them.

"I'm going to be rude and blow on your face," he says, trying to dry some of the glue he's just dabbed on the teen's nose, as he attaches the new rubber nose. Another girl walks up, "I'm going to be Cuddles," she exclaims, smiling with pleasure.

EDITORIAL

UNFAIR, INCONSISTANT, UNQUALIFIED JUDGES? by Bob Stoddard

"The judges are not consistant." "Judges rate high for the old established, mediocre clowns while passing over outstanding new clowns." "Contest judges are not qualified to pick the best clowns. The same clown can take first place in one contest and not even place in another." "I spent hundreds of hours of study before deciding on my face and costume and I know it was first place quality, but the judges didn't even consider me." "The judges are unfair. They

pick the people that they like."

These are only a few of the complaints that I have received from clowns who didn't place in competitions that we have presented. Sometimes the questions were asked through tears or in agner. We've all heard similar grumblings after competitions down through the years. And they weren't all clown competitions. It's the same in all types of competitions where judges are involved. Even T.V.'s Judge Wapner gets complaints. Hence, my decision to address the problem of the inconsistant and unfair clown judges and confront the amateur's sense of rejection.

"The judges are inconsistant," seems to be the major complaint. "Last year I won first place in the Tramp competition. This year I had on the same identical costume and make-up and I only won fourth place," said one of our TCA clowns last year during the business meeting after the Plano competitions. "How

come?"

This only proves that one thing was identical this year (as compared to the previous year) and even that is suspect because, in the course of a year, he was bound to have made some changes (or should have - probably for the better). The rest of the contestants were different, or evidently improved in the eyes of the judges, who were different - if not in person, but in the fact that they were a year older - if nothing else.

Like the song says, "Time changes everything."

"Judges rate high the old established, mediocre clowns while passing over outstanding new clowns." In this case, "mediocre" was the questioner's opinion. The "old established clown" was one who had won several contests that made him qualify for the "old and established" classification. Yes, it is true that nothing succeeds like success. Judges are often influenced by the fact that, "he/she did it before and he/she can do it again." Judges aren't infallible: they are often not sure of their own ability and let the decisions of judges before back up their current decisions. On the other hand, if the judge had never seen or heard of the contestant, his decision might have been different. That seems unfair and, in this imperfect world, that's the way it is sometimes.

Sometimes the "old established clown" knows what it takes to please the judges. Another reason could be that the "established clown" may seem to be "mediocre" or below average because the viewer doesn't have the background or

experience to understand or appreciate subtle things that the judges see.

At Plano last year, one tramp clown was irrate because a judge rated

At Plano last year, one tramp clown was irate because a judge rated him low on originality. "How," he asked indignantly, "can you have any originality in a tramp clown make-up and costume when it's been established, for many years now, what we should look like?" Yet he knew that he was different (and better) than all of the other tramps—and where there is difference, there can be

originality.

The thing about tramp clowns that makes me wonder is: how can a 23-year-old man, or-worse yet--a porcelain-smooth faced woman-expect to compete in a contest with a man like the late Bob "Rags" Thomas whose character lines in his 76-year-old face probably spelled T-R-A-M-P if you traced them with your finger. He knew the kind of pout or expression that the judges liked. He really looked like a tramp, or--should I say--he looked like a real tramp, while his competition looked like people dressed in brightly patched, ill-fitting clothes.

If you let your character grow by what you have learned from contest judges, you may be destined for some frustration. There are too many facets involved in the decision-making process. I know a contest judge who is sick of

seeing too many one-piece jump suits on clowns. An average costume (other than a jump suit) would have a better chance, in his honest opinion. Something fresh and new would excite another judge. This might be a reason why the judges didn't notice you.

Contests are also affected by the quality of the overall competition. Some attract many excellent entries, while others attract few entrants, the winner

of which wouldn't place at all in the first contest.

"How come you put their picture in the paper and you didn't put mine in?" "You never gave me your picture."

That one was easy but here's another one. "How come she has a full page of pictures in the paper and I don't have any--and I'm a better looking clown than she is?" Wow! I'm afraid that this explanation is too much for me to tackle. Let me say this. When I had the first (of four) Clown and Circus Days at the State Fair of Texas, I ran it all alone. Jay Dickman, a <u>Dallas Morning News</u> photographer, took several pictures, one of which I thought was great. I picked five or six of the people who were knocking themselves out helping me, and had them in a circle like a football huddle and Jay took their picture from below. They all radiated out from the center where they seemed to be joined at their heads. Jay was convinced that it was a great shot. I was happy that this picture in the Dallas Morning News would be a fitting reward for these people who helped me.

A clown walked up to me in make-up and costume and said in her crisp English accent, "Mr. Stoddard, I am Edna Flanagan, Crackers the Clown from Fort Worth. I have an invitation from your wife to visit her clown portrait booth in the Women's Building and an invitation from you to participate in your affair. I have a clown job in Dallas shortly and I can only accept one invitation. You

choose.

"Well," I said, "as long as I've been married I guess you should accept her invitation, but before you go, let Jay get your picture."

Jay stuck his camera in her face and moved quickly about, clicking off

seven or eight shots.

The next morning, on the newsstand, the first thing I saw was a six column, twelve-inch full color photo of Crackers on the top half of the front page. Jay told me that his pick was the one we liked but the lay-out man had a mind of his own and overrode the Pulitzer Prize winning photographer. So much for the reward for those who helped me.

No matter where you stand on these issues, it seems to me a waste of time

and creative energy to attack the clown establishment with bitterness.

Yes, sometimes the judges make mistakes (as we all do), and when I decide that he was wrong, I put myself in a position where I am judging him--and my judgment of him may be as wrong as his judgment of me. However, I appointed myself as his judge, which had nothing to do with the contest. He was an official judge and it was his job to pick his choice of winners. I think that judges do this as fairly as they can. But differences in taste as well as practical considerations will always exist. There is not much that can be done to change this situation.

In our family, each of us has our own pick for the Miss Texas Pageant. Miss America or Miss World--whatever. Sometimes their judges agree with one of us--sometimes not--but we realize that they were the judges--not us. If we were the judges, things would have been different. We would have four people tie for first place. And we all know that we are the best judges of beauty--honest!

Yes, it's true that the world isn't fair; that you may be a better clown than those judges think you are and that they may be inconsistant and open to influence, but your success is not dependent on their decision. Just keep on

doing what you enjoy and have fun doing it.

I just can't see where people find fun in griping, bitching, whining or counting misspelled words and typos.

It's no fun being around those kinds of people either. Boo on bellyachers!

Materials: A hard cover book about two inches thick, a bottle of white glue (Elmers), A cig. lighter that uses lighter fluid, NOT BUTANE, 100% cotton balls, lighter fluid, paper to make a cover with, and a marker to make a title with.

<u>Caution:</u> Be very careful when using this while wearing gloves.

The only tools you will need is a single edge razor blade, or a box opener.

The How To: Open the book to about k of its thickness. Measure and mark 3/4 inch from each edge of the page on the right hand

Using the razor blade, cut along the lines you have marked through about 4 or 5 pages at a time. Reep cutting through the pages until you have made the hollow 3/4 to 1 inch deep. Trim all stray cuttings.

Coat the entire page and hollow with a fairly thick coating of white glue. Also coat the opposite page. After this has dried, add another thick coat of glue then add a third coating. This is to fire proof the book.

Place the cig. lighter in the lower right cornor of the hollow. Hold the book in your right hand and position the lighter so you can strike it with ease with your right thumb. Glue the lighter in place.

USE WHITE GLUE ONLY. DO NOT USE A FLAMABLE GLUE.

Glue the cotton in place in the bottom of the hollow. Make sure you use

Glue the cotton in place in the bottom of the hollow. Make sure you use 100% cotton. The fake stuff will melt and cause a real mess.

To operate: Just before your performance, fill the cig. lighter with lighter fluid. Wet the cotton with lighter fluid but be careful and not over do it. Strike the lighter with your thumb making sure to not get lighter fluid on your gloves when doing so. Your hand being on fire may be thought of as part of your act from spectators but will be a diaster for you.

To put the flame out all you have to do is close the book. This is a great prop to play "Look but don't see" with.

This is a great prop with KIDS but please use it with extreme caution.

I would like to thank everyone for coming to the Prop Shop at the convention in Midland. I think it was a great convention and a lot of clown knowledge was shared with all.

ARTICLE I IDENTIFICATION

- Section 1. Name: The name of the corporation is Texas Clown Association.
 Inc.
- Section 2. Principal Office: The principal office of this corporation shall be located at 2113 Red Oak Drive, Irving, Texas 75060.
- Section 3. Seal: The seal of the corporation shall be in the form of a circle and shall bear the name of the corporation and the year of its incorporation.
- Section 4. Fiscal Year: The fiscal year of the corporation shall be the calendar year.

Section 5. Purpose:

- 1. Promote, preserve and improve the profession of clowning
 - Provide the opportunity to study the art, history, and philosophy of clowning
- Educate its members and the general public in the wholesome and clean entertainment that is provided by the profession of clowning
- To provide news to the members of all clown events in the state of Texas
- To provide all members a regular publication of the corporation magazine called the "Joey Journal"

ARTICLE II MEMBERSHIP

Section 1. Membership: Membership shall be open to any resident of the state of Texas sixteen (16) years of age or over desiring to pursue the ancient and honorable art of clowning, and who is dedicated to its advancement, provided the provisions of the By-Laws are fulfilled.

All propespective members must submit an application for membership that sets forth their home address, age, clowning experience and a statement of their reasons for wanting to become associated with the Texas Clown Association, Inc., and their willingness to uphold the Code of Ethics of clowns. All applications shall be reviewed by a majority of the Board of Directors and approved by a majority of the board.

- Section 2. Associate Membership: Associate membership shall be open to anyone over the age of sixteen (16) desiring to be a part of this association without the rights of a regular member. This includes anyone out of the state of Texas or anyone with an interest in the art of clowning. Associate members will not have voting rights and will pay only half the regular annual dues.
- Section 3. Junior Membership: Junior Membership shall be open to anyone ten (10) through sixteen (16) years of age. Junior members will not have voting rights and will pay only half the regular annual dues. Junior members are required to have a sponsoring member in good standing.
- Section 4. Membership Annual Dues: Membership dues are due October 1 of each year. New memberships will be prorated at time of application. Any member delinquent in payment of their dues for more than ninety (90) days shall be dropped from the member-

ship rolls of the corporation. Annual dues for membership and charter fee for chartering of alleys shall be set by the Board of Directors.

Section 5. Membership Meetings: The annual membership meeting of the general membership shall be held at a time and place designed by the Board of Directors. The general membership shall be notified in writing thirty (30) days prior to the annual membership meeting.

ARTICLE III BOARD OF DIRECTORS

- Section 1. Numbers and Authority: The affairs of the corporation shall be conducted and managed by the Board of Directors which shall exercise the powers of the corporation. The board shall be composed of eleven (11) members: four (4) officers; President, Vice President, Secretary, and Treasurer each elected from the general membership; six (6) Regional Directors each elected from their respected regions of the state of Texas; and the immediate past President will automatically be a member of the board.
- Section 2. Executive Committee: The Executive Committee shall be composed of three (3) members: President, Vice President, and Secretary. The Executive Committee shall be empowered to act on behalf of the Board of Directors in the case of an emeragency.
- Section 3. Editor of the Joey Journal: The editor of the Joey Journal will not be a member of the Board of Directors and cannot be granted voting rights as such. The editor will be appointed and goverened by the Board of Directors.
- Section 4. Offices of the Board of Directors: No one individual can hold two (2) offices on the Board of Directors.

ARTICLE IV DUTIES OF THE OFFICERS AND DIRECTORS

- Section 1. President: The duty of the President shall be to preside at all meetings of the corporation and to supervise the affairs of the corporation. The President shall appoint any committee needed to promote the purposes and objectives of the corporation. The President shall be an ex officio member of all committees.
- Section 2. Vice President: The duty of the Vice President shall be to discharge the duties of the President when the President is absent or unable to preside. The Vice President shall perform such other duties as assigned by the President.
- Section 3. Secretary: The duty of Secretary shall be to keep all records and correspondence of the corporation. These records shall include but not limit to: membership roster, minutes of all meetings of the officers, directors, and general membership. The Secretary shall also answer correspondence for the corporation when requested by the President and shall keep an accurate file of all correspondence and shall be the keeper of the corporate seal.
- Section 4. Treasurer: The duty of the Treasurer shall be to render a financial statement report for the corporation to the Board of Directors and the general membership at the annual meeting and a quarterly financial statement shall be provided to the Board of Directors. The Treasurer shall also conduct all corporate

financial transactions including collecting and dispersing funds. The Treasurer's duties shall also include sending out membership cards, membership applications, and recording same.

- Section 5. Regional Directors: The duties of the Regional Directors shall be: promote membership and make recommendations to the Board for new applicants in their region; make a bi-monthly and annual report of activities and accomplishments in their region and gather news, information, etc. in their region and report to the Secretary and the Editor of the Joey Journal.
- Section 6. Board of Directors Vote: A majority vote of the Board of Directors shall constitute a quorum for the transaction of business, provided all members of the Board were duly notified of a meeting. The vote of a majority of the Board of Directors present at any duly constituted board meeting shall be sufficient to take any action, unless otherwise limited by these BV-laws.
- Section 7. Board of Directors Vacancy: Any interim vacancy occurring for any reason on the Board of Directors may be filled by an appointment of the Board of Directors until the next election for that position is held.
- Section 8. Remuneration: No officer or director shall receive any pay or remuneration for serving in that position. Reimbursement for expenses incurred on behalf of the corporation are not to be considered as remuneration.
- Section 9. Removal of a Board of Director: Members of the Board of Directors, by a two-thirds (2/3) majority vote of the members present at a duly constituted board meeting, shall have the power to remove a director who is incapable for any reason of performing his duties.

ARTICLE V ELECTION AND BALLOTING

- Section 1. Nominations: The nominations of officers shall be made by a nominating committee appointed by the President. The committee shall submit their nominations in writing at least thirty (30) days prior to the annual membership meeting. Any five (5) members in good standing may submit a name in nomination thirty (30) days prior to the election and it will be on the ballot. Nominations can be made from the floor at the annual convention.
- Section 2. Ballot Count: All ballots which are legible will be tallied and the results will be announced at the annual membership meeting. All newly elected officers and directors will take office at the conclusion of the meeting.
- Section 3. Re-election:
 - Any member of the Board of Directors shall be qualified to succeed himself at the expiration of his term.
 - All officers shall be elected for a period of one (1) year.
 - Regional Directors are elected for a two (2) year term.
 Thus dividing the regions into two (2) groups. One group
 take office at the regular annual membership meeting
 while the other holds its office until the following
 annual membership meeting.

- Any voting member of the corporation may qualify for election to the Board of Directors.
- The office of President will be held by a member or a former member of the Board of Directors.
- No officer or director shall succeed himself in that office for more than three (3) consecutive terms.
- Section 4. Absentee Voting: Any member unable to attend any general membership meeting will be able to vote absentee. All absentee ballots must be received five (5) days prior to any scheduled general membership meeting to be counted. All official ballots must be signed by a member and include membership number.

ARTICLE VI AMENDMENTS

Section 1. Rules Regarding Amending:

- The By-laws may be amended at any regular membership meeting or a special membership meeting called for the purpose of amending the By-laws providing that thirty (30) days written notice was provided stating the proposed amendment to all the membership.
- Any proposed amendment may be made by a minimum of five (5) members in good standing and the proposed amendment shall be submitted in writing to the membership thirty (30) days prior to the membership meeting.
- A vote of two-thirds (2/3) of the membership/absentee ballots present at any duly constituted meeting shall be necessary to amend the By-laws.

ARTICLE VII RULES AND REGULATIONS

Section 1. Parliamentary Procedures: All corporate meetings including general membership meeting, Board of Directors meetings, and committee meetings shall be conducted to the <u>Roberts Revised</u> Rules of Order.

ARTICLE VIII DISSOLUTION

Section 1. Termination of Corporation: In the event of dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all assets of the corporation:

exclusively for the purpose of the corporation in such manner, or to such organization(s) organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization, as determined by the Board of Directors.

ARTICLE IX CHARTERING OF ALLEYS

Section 1. Definition: Any five (5) or more Texas residents over the age of 16 years and a Texas Clown Association Member (here-inafter "Regular Member"), in good standing with T.C.A. may organize and form a local chapter for convenience purposes in order to coordinate and carry out the goals and principles of T.C.A. and it shall be called a Clown Alley. A Clown Alley shall not be construed as an agent, servant, or employee of T.C.A. and shall have no right, power, or authority to bind, obligate, or otherwise render T.C.A. liable for its actions or conduct.

Charter: After submitting the appropriate application, T.C.A. Section 2. may grant a charter to Clown Alley, the effect of which is to recognize the formal grouping of members in order to better carry out the principles of T.C.A., Inc. and the acceptance of which requires the Clown Alley to comply with the charter. by-laws, rules, and regulations of T.C.A.

The charter application shall include the names and addresses of the members and officers, the latter consisting of a:

President Vice President Secretary

Treasurer Parliamentarian or Board Member

The application shall be signed by an acting chairman of the application group, and it will be forwarded to the President of T.C.A. for review and approval and sent to the Board of Directors for approval. Within sixty (60) days after receipt of the application, the President shall respond to the applicant group with an indication of approval or disapproval.

If approved, the applicant Clown Alley shall forward a charter fee to the T.C.A. Treasurer.

- Internal Rules and Regulations: Clown Alleys may prescribe Section 3. such rules, regulations and provisions as they deem necessary and suitable to carry out their own organization, but the same shall not, in any way, be in conflict with, nor exceed the powers or principles laid down in T.C.A. by-laws. Clown Alleys may have Junior and Associate Members, not a member of T.C.A., but Junior and/or Associate Members cannot vote or hold office.
- Reports: By the first of September each year a chartered Section 4. Clown Alley must submit to the President and their area representatives a complete listing of all names and addresses of of the members and officers of the Clown Alley, along with a financial statement which includes the assets and liabilities of the Clown Alley for the period ending the preceding calendar year.
